DESCRIPTION OF BUILDING PRODUCT

The Armstrong InvisAcoustics – Under Slab Ceiling Panel System comprises InvisAcoustics panels and an aluminium fixing system (the system).

The system is supplied to Comfortech® by [Armstrong Ceiling Solutions](#) (Australia) Pty Ltd for supply in NZ.

Direct fixed InvisAcoustics panels don't contribute to the building code compliance of a building. However, Comfortech® have elected to prepare a BPIR declaration.

The use of the system is intended where the ceiling for an occupied space is the exposed concrete slab. By direct fixing InvisAcoustics panels the space becomes quieter and less reverberant.

This BPIR includes all elements of the system that are supplied to Comfortech® by Armstrong for the installation and ongoing performance of the system.

The InvisAcoustics panels are manufactured from [Optra](#) glasswool covered with scrim to which a factory-applied acrylic paint has been applied to all surfaces and edges.

The fixing system is a proprietary aluminium fixing system comprising a mounting grid and hanger clips.

The panels are 20 or 30 mm thick, and the fixing system provides a 30 mm gap to accommodate electrical cables.

When tested by [BRANZ](#), the Optra achieves a material group number 1S which may also be applied to InvisAcoustics panels.

Armstrong Ceiling Solutions is an Australian company, that has been in operation for more than 60 years. It has [Green Tag Certification](#) and a [Platinum Product Health Declaration](#) in respect of many of its products including those supplied by Comfortech®. The Product Health Declaration is a whole of life assessment.

CONTRIBUTION TO BUILDING WORK CODE OBLIGATIONS

The Armstrong InvisAcoustics – Under Slab Ceiling Panel System does not contribute to the code compliance of the building work.
