### DESCRIPTION OF BUILDING PRODUCT & MANUFACTURER

Comfortech® supplies coatings for the protection of steel and concrete structures. The coatings are manufactured by Promat under the CAFCO® brand.

Application of these coatings must be carried out or supervised by a trained person.

#### CAFCO® FENDOLITE® MII

The coating is a factory-controlled premix based on vermiculite and Portland cement. It is mixed with potable water to a slurry and either spray applied, finished with a roller, or floated. It may be used in exterior and interior applications.

It produces a monolithic coating that is able to withstand thermal shocks. The coating retains moisture so, in the event of a fire, this moisture turns to steam. This delays the increase in temperature and provides fire resistance during this period.

CAFCO® FENDOLITE® MII is suitable for use with concrete and steel substrates and may also be used in the upgrading/refurbishment of tunnels.

#### CAFCO® 300

A coating pre-mix based on vermiculite and gypsum. It is mixed with potable water to a slurry and either spray or trowel applied to create a monolithic coating.

It is intended for internal applications and with steel frames, metal floors and roof decks or concrete substrates.
