DESCRIPTION OF BUILDING PRODUCT

Comfortech® supplies steel furring channels and brackets for use in the installation of direct-fixed and suspended ceiling and wall panels.

Furring channels are are manufactured from 0.42 BMT steel and supplied with depths of 18 mm or 28 mm, widths of 38 mm or 60 mm, and in lengths up to 6m.

The wide-faced furring brackets are manufactured from steel gauge 0.75 – 1.15 and in a range of widths and lengths to suit application.

The furring channels and brackets are manufactured in Australia by [Siniat](#). Siniat is part of the Etex Group, a large global company that specialises in lightweight building products.
