DESCRIPTION OF BUILDING PRODUCT

Comfortech® supply a range of soft fibre acoustic products, branded Soundscape. Comfortech® source these products from [Armstrong Ceiling Solutions](#) (Australia) Pty Ltd (Armstrong).

The Soundscape products are manufactured from glass wool (80% recycled content) with a factory painted scrim finish. Product options include,

- pre-formed convex and concave shapes and canopies, and
- baffle and baffle curves.

Soundscape soft fibre acoustic products do not contribute to the building code compliance of a building but, despite this, Comfortech® have elected to prepare a BPIR declaration.

The products are fixed to roof structure by one of three ways,

- suspended individually with aircraft cables,
- fixed directly to plasterboard with clips, or
- suspended as a group with a combination of frames, hooks and cables.

The products have been tested by [BRANZ](#) and achieve a material group number 1S.

Comfortech® supplies proprietary fixings supplied by Armstrong.

The Soundscape soft fibre acoustic products improve the acoustics of a space by absorbing sound or by reducing reverberation. They can have the effect of lowering the ceiling, improve light reflectance, and can be used to create discrete spaces within a larger space.

This BPIR covers all Armstrong products supplied by Comfortech® associated with the installation of the Soundscape products.

An Australian company, it has been in operation for more than 60 years. **Armstrong Ceiling Solutions** has Green Tag Certification and a Platinum Product Health Declaration in respect of many of its products including those supplied by Comfortech®. The Product Health Declaration is a whole of life assessment.

CONTRIBUTION TO BUILDING WORK CODE OBLIGATIONS

Soundscape soft fibre acoustic products do not contribute to the code compliance of the building work. However, when suspended, they must be installed in accordance with AS/NZS 2785:2020 Suspended Ceilings – Design and Installation.
