2.3 Other hazards

HOWEVER, FOR THIS PRODUCT, WITH EXPOSURE ASSESSMENTS PERFORMED BY ACCREDITED EUROPEAN LABORATORIES USING REFERENCE WORKPLACE MONITORING METHODS, ANY QUARTZ LEVELS IN THE RESPIRABLE DUST WERE BELOW THE DETECTION LIMIT. INHALATION OF HIGH CONCENTRATIONS OF DUST MAY IRRITATE THE AIRWAYS. DUST MAY ALSO CAUSE IRRITATION TO THE EYES AND/OR SKIN. Symptoms of exposure include itchy, tender, swollen, hot, cracked or blistering skin with the potential for sensitisation. The dermatitis is due to the presence of soluble (hexavalent) chromium.
