DESCRIPTION OF BUILDING PRODUCT

Comfortech® supplies the Studco Building Systems Pty Ltd concealed ceiling framing system, intended for use with direct or suspended ceilings.

Studco is an Australian company that was founded in 1986. It supplies a range of roll-forming and other building products, in addition to those supplied by Comfortech[®].

The framing systems covered by this BPIR do not contribute to the building code compliance of a building. However, Comfortech[®] has elected to prepare a BPIR declaration.

This BPIR declaration covers all products supplied by Studco in respect to the installation and ongoing performance of their concealed framing systems and that are supplied in NZ by Comfortech[®].

The framing system components are roll-formed from galvanised steel manufactured by Blue Scope and comprise top cross rails, furring channels, battens, clips and joiners for direct fixed, and suspension rod, top cross rail, battens and clips where the ceiling is to be suspended. The system components are supplied in a variety of sizes to suit the ceiling lining dimensions.
